#### Job Purpose:

Reporting to the Dental Clinic Manager (DCM), the Dental Hygienist (RDH) is a valued member of the dental care team that possesses the knowledge, skills and professional responsibility to promote oral health and oral health protection and prevention strategies for the clients they serve. In the clinic the RDH will work both independently and together with other Dental Health Care Providers (DHCP) to meet the oral health needs of clients.

The RDH will provide culturally sensitive oral health services for diverse clients throughout their life cycle. They will work collaboratively with clients, guardians and other professionals to enhance the quality of life of their clients and the public. Dental care will follow the dental hygiene process of care: assessment, diagnosis, planning, implementation and evaluation (ADPIE). Duties will include intra oral and extra oral examination, oral cancer screening, periodontal assessment and debridement, prescribing and taking of radiographs, diagnosis of dental caries and periodontal disease, oral hygiene instruction, dietary counselling, polishing, application of preventative agents like fluoride and sealants, application of caries arresting agents like silver diamine fluoride, and application of desensitizing agents. The RDH will also follow current guidelines on infection control and instrument reprocessing.

This position involves working with NECHC staff, dental clinic staff, Dalhousie Dentistry faculty, dental students, dental residents and dental hygiene students. It is important to be an effective team player, a good communicator and have the ability to work independently.



### **Education and Experience:**

- Diploma of Dental Hygiene or Bachelor of Dental Hygiene
- 2+ years' experience as a RDH in a community setting.
- Experience using electronic medical/dental records.
- Experience working in not for profit and health care setting preferred
- Experience working with diverse communities
- Experience working with disease management, risk prevention education
- Experience working with clients with mental health and addiction problems as an asset.
- Experience working with children is preferred.

### Certification/Registration/Designations:

- Registered and licensed to practice (in good standing) Dental Hygiene with the NSRDHDTD Membership in the NSDAA and CDAA
- Authorization to self-initiate and administer local anesthetic

## **Position Responsibilities:**

The following duties reflect the broad scope of responsibilities but are not necessarily all-inclusive.

#### **Clinic Preparation & Infection Control**

- Stocks and prepares treatment rooms in accordance with current NSRDHDTD infection control guidelines.
- Maintains hygiene instruments: inspects, sharpens, sterilizes, labels, and documents processes per clinic protocol and manufacturer's instructions.
- Adheres to policies that protect clients, staff, and self, and supports dental assistants as needed.

#### Client Care & Communication

- Prepares patients by welcoming them, providing PPE, updating health history, explaining treatment plans and options, answering questions, and obtaining consent.
- Provides clear information to clients, staff, and management in response to questions or concerns.
- Offers oral hygiene instruction, post-op care guidance, and dietary counseling.



#### Dental Hygiene Services

- Conducts intraoral/extraoral exams, oral cancer screenings, periodontal assessments, and debridement.
- Takes and prescribes radiographs, diagnoses caries and periodontal disease, and administers local anaesthetic.
- Applies preventive agents (fluoride, sealants), caries-arresting agents (e.g., silver diamine fluoride), and desensitizing agents.

#### **Documentation & Record Management**

- Updates and signs medical and dental records; accurately records services, billing codes, and treatment plans in a timely manner.
- Maintains charting systems, ensures electronic record accuracy, and upholds confidentiality standards.

#### Team Support & Ethical Practice

- Supports colleagues and the care team as needed.
- Upholds infection control policies, clinic protocols, and the NSRDHDTD Code of Ethics.
- Practices within personal limitations and legal scope as defined by federal/provincial regulations.
- Reports unethical, unsafe, or incompetent services to management and relevant authorities.

#### **Client-Centered & Culturally Safe Care**

- Respects client autonomy and includes them in all care decisions.
- Evaluates health/oral health using risk and determinant assessments to guide care and referrals.
- Designs and delivers culturally sensitive, community-appropriate services.

#### Professionalism & Development

- Promotes healthy behaviors among clients, peers, and the public.
- Recognizes and responds to political, social, and economic health influences on populations.
- Self-assesses performance, creates professional development plans, and engages in NSRDHDTDmandated quality assurance programs.
- Promotes social responsibility and works to advance the common good.

#### Other Duties

• Performs additional tasks as directed by the Dental Manager (PCM) or Director of Primary Care.



## Professional Knowledge, Skills and Abilities

## Working Environment and Unavoidable Hazards:

- Moderate physical effort is required to perform this role including lifting, repetitive motion, standing, reaching, sitting, pushing/pulling.
- Supportive, exciting, and challenging.
- Exposure to usual hazards of health care center.

### Judgement and Initiative:

- Must be able to work with a high degree of autonomy and demonstrate critical thinking and sound judgment
- Must be highly motivated, proactive, and creative
- Be committed to professional education/development, collaborative decision-making, and team development.
- Expected to fulfill all activities related to the role with a minimum degree of supervision

#### Safety (Patient, Worker and Workplace):

- The employee will demonstrate good stewardship in the identification, reporting and mitigation of unsafe acts or conditions.
- Provide current immunization records (tetanus, diphtheria, polio, measles, rubella, chicken pox, hepatitis B) Hepatitis B surface antibodies (6 weeks post- test) and have the 2 step Mantoux (tuberculin).
- Willingness to complete NVCI course and/or de-escalation training.
